#### GENERAL INSTRUCTIONS

#### Mixing/Application

Invert original container before use. For best results form a premix of the required amount of product with an equal volume of water. Stir thoroughly. Add to spray tank and dilute with remaining amount of water. Agitate thoroughly. Do not store diluted insecticide. Prepare a fresh solution as necessary.
